### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, AND INDEMNITY AGREEMENT

#### I understand:

1. The nature of the activity and that I am in good health to participate.
2. That the game may require extreme exertion and if I do not feel well I will notify a member of staff.
3. That I must participate in accordance with the stated rules / safety briefing which I have read / listened to and understood.

#### I confirm and agree that:
